- Strategic Plan (2018-2022): Ensuring food security & developing policies for a competitive and sustainable agricultural sector is the main aim of Turkish agricultural policy.
- \* Turkey produces a wide range of agricultural products but is a leading world producer and exporter of nuts, dried fruits, and some fresh vegetables.
- \* The trend in importing raw materials, inputs for agriculture such as **feedstuffs, maize** and **soya beans** along with **cotton, wheat** and **tobacco**.







- \* In a broad sense, trade costs cover wide range of components affecting the trade such as logistics (infrastructure), transportation (distance and maritime connectivity), non-tariff barriers, transit passage and customs procedures.
- Trade cost is closely linked with trade facilitation and refers to duration of customs procedures and length of documentary compliance both for exports and imports.



### **TRADE FACILITATION**



- Fruits and vegetables (which constitute a considreable amount in intra-OIC agricultural trade) are **perishable** and without sophisticated transport, logistics or packaging, difficult and/or more costly to transport long distances.
- \* Therefore, trade of **perishable products** is quite concentrated between OIC member countries particularly in close vicinity.



### **TRADE FACILITATION**



- \* 33 of OIC member countries including **Turkey** ratified WTO's Trade Facilitation Agreement (TFA)
- \* Article 7.9 refers specifically to «Perishable Goods».
- \* To avoid loss or deterioration of perishable goods, each Member shall provide for the release of **perishable goods** within the shortest possible time;
- \* Each Member shall give priority to **perishable goods** when scheduling any examinations that may be required.



## **SPS & TBT MATTERS**



#### **Challenges:**

- \* Non-uniformity of SPS and TBT regulations across OIC members
- Complex procedures in the way and to the detriment of intra-regional trade
- \* Lack of standardized products

#### **Suggestions:**

- Due respect to ALOP signifying that a measure should not be more traderestrictive than required
- \* Harmonization of SPS & TBT Legislation and Standards in line with the guidelines of OIE, IPPC and Codex Alimentarius in the OIC Region



### **SPS & TBT MATTERS**



#### Suggestions (cont'd):

- \* Simplification of import/export requirements
- Close follow-up of changes in SPS and TBT related legislation of OIC member countries.
- Paying more attention and giving appropriate responses to comments for SPS and TBT notifications to the benefit of OIC area



## PREFERENTIAL TRADE AGREEMENTS



#### Suggestions:

- Conclusion of PTAs among all OIC member countries in terms of trade creation to the benefit of OIC area
- \* Impeding trade diversion caused by FTAs of third parties
- Revision of existing agreements among OIC member countries with the aim of further reciprocal concessions for agri-food trade
- \* Rules of origin, safeguard measures and SPS matters...



## PREFERENTIAL TRADE AGREEMENTS



- \* FTAs already concluded: Palestine (2005), Tunisia (2005), Morocco (2006), Syria (2007), Egypt (2007), Albania (2008), Malaysia (2015).
- \* FTAs pending internal approval procedures: Lebanon, Sudan and Qatar.
- Ongoing FTA negotiations: Cameroon, Gulf Cooperation Council, Libya, Djibouti, Chad and Pakistan.
- \* Intention to negotiate an FTA with Algeria.

## ICT USE IN AGRICULTURE



- Total employment in agriculture has been gradually decreasing in many of the OIC countries.
- \* In order to feed the existing or growing populations and ensure selfsufficiency, it is essential to increase productivity.
- \* <u>Challenge:</u> Inadequacy of agricultural mechanization, productivity, packaging and warehousing systems in many members of the OIC
- Suggestion: Digitalization is supposed to play a role in reduction of costs. It is also a must to tailor the production methods and to produce FMCGs so as to serve the demands of the consumers in the OIC area.

- \* Coordination and cooperation with the OIC Member Countries
- \* Facilitation of intra agrifood trade in particular
- \* SPS and TBT sensitive approach in the region
- \* Conclusion of new PTAs
- Revision of existing PTAs in order to deepen the preferential agri-food trade among OIC members
- \* Uniformity for Halal standards
- \* Organization of Agribusiness Forums
- \* Necessary infrastructure and ICT use in Agriculture
