Ankara Agreement

- The aim of the Ankara Agreement is to promote the continuous and balanced strengthening of trade and economic relations between the Parties.
- In order to attain these objectives a customs union shall be progressively established following a preparatory and transitional stage.
- The final stage would be based on the customs union.

Additional Protocol

- The EEC abolished customs duties on industrial imports from Turkey as of 1971.
- Turkey's elimination of tariffs schedule started in 1973 and lasted till 1996,
 when the Customs Union was established.



Customs Union

- Following the transitional period, Turkey-EU Association Council set out the basic principles and procedures of the Customs Union between Turkey and the EU through the Decision No.1/95.
- The Customs Union (CU) between Turkey and the EU was completed on 31 December 1995.
- Turkey-EU Customs Union establishes the free movement of goods between the parties and has a comprehensive context covering a wide range of policies.



Scope of the Customs Union

- Customs Union basically covers industrial goods.
- In addition to the industrial products, processed agricultural goods are included in the Customs Union only for industrial components.
- Basic agricultural goods are not included in the Customs Union. Bilateral trade of agricultural products between parties is carried out in accordance with the Association Council Decision (ACD) No. 1/98.
- Products covered by the European Coal and Steel Community are outside of the Customs Union. Bilateral trade of the said products between parties is carried out in accordance with Turkey - ECSC Free Trade Agreement.
- Trade in services, investments and public procurement are not included in the CU.




Common Commercial Policy

- Application of the Common Commercial Policy;
 - **Common Customs Tariffs** on imports from third countries, (for some sensitive products application of CCT had been postponed until 2001)
 - Common customs procedures on imports and exports,
 - The **same autonomous and bilateral preferential regimes** towards third countries.
- Turkey has signed 32 FTAs, eleven of which have been terminated due to the enlargement of the EU in May 2004 and January 2007. Currently, 17 of these FTAs are in force
- Automous regimes includes Generalized System of Preferences (GSP) towards developing countries and the Everything But Arms for least developed countries.




Turkey's Exports and the Share of the EU





Turkey's Imports and the Share of the EU
















Imports
