Results of the Questionnaire Circulated by the SESRIC to the Member Countries on the Proposed Themes for the COMCEC Exchange of Views Sessions

Background

The 30th Meeting of the Follow-up Committee of the COMCEC, held in Ankara on 7-8 May 2014, requested SESRIC, in its capacity as the coordinator institution of the exchange of views sessions of the COMCEC, to explore the views of the member countries on each of the following four proposals as possible themes for the exchange of views sessions to be held during the subsequent COMCEC Sessions through circulation of a special questionnaire to the member countries and analysis of their responses on the subject matter:

Theme 1: Post-2015 Development Agenda and Development Challenges of Islamic Ummah

Theme 2: Enhancing Aid Efficiency and Developing Effective Aid Strategies and Policies

Theme 3: Promoting Islamic Financial Services in the OIC Countries

Theme 4: Utilization of the Islamic Waqs to mobilize the resources for alleviating poverty in the OIC Member States

The Committee also encouraged the Member States to promptly response to the SESRIC questionnaire on the theme-selection to enhance related procedures and end up with a better identification of the areas where there is need and demand by member countries.

The Centre, therefore, circulated a questionnaire on the subject matter (a copy is attached to this document) to all the member countries on 14 May 2014 and requested them to complete it and return it to the Centre by 30th September 2014 at the latest to enable the Centre to analyse their responses and report accordingly to the 30th Session of the COMCEC on 25-2 November 2014 in Istanbul.

The Centre received responses from only 15 member countries, namely Afghanistan, Azerbaijan, Egypt, Iran, Kuwait, Jordan, Lebanon, Oman, Niger, Qatar, Pakistan, Saudi Arabia, Suriname, Togo and Turkey.

This report presents the results of the responses of these member countries in terms of their prioritisation of the above-mentioned five themes.
