#### Reform Formalities and Documentation Requirements

## Simplification of formalities and documentation requirements

- efficiency at borders
- decline in compliance costs and time for traders.

#### Use of customs brokers

- help traders to complete some customs formalities faster
- ensure that their import shipments meet all of the requirements set forth by the customs authorities.

## Common border procedures and uniform documentation requirements

- to comply with the same procedures and submit the same documents for the same goods regardless of the point of entry to a country
- •some further considerations can be made depending on the means of transport and risk management principles.

#### Rejected goods

- •reject the import of goods only on the basis of non-compliance with technical or SPS requirements
- •allow importers to re-consign the goods or return them to the exporter

#### Temporary admission of goods

•receive special treatment to improve efficiency

**E-Signature**

### **Establish National Inter-Agency Coordination Mechanisms**

Authorize this agency to advice and set up binding rules and procedure

Design special measures to expedite the pandemic related goods by Customs and SPS agencies

Release necessary information in coordination with all stake holders

Report regularly to the committee on the implementation and impact of the recommendations made

## **Strengthen Cross-Border Agency Cooperation**

Coordinate with partner countries

Establish a consultation mechanism

Design early warning systems across borders

Disseminate information between ports

Utilize similar automation systems across borders

Determine the pandemic related products that are pretested in home countries fulfilling the import requirements

Determine essential pandemic related products produced under similar processes across trading partners

Implementation of the recommendations of international organizations

#### Improve Publication and Availability of Information

Establish trade portals and websites to allow for more transparent dissemination of trade rules and regulations

Establish enquiry points to answer reasonable enquiries

#### Develop National Emergency Trade Facilitation Plan

Establish a national committee

Governmental and non-governmental representatives

Prepare legislations for expediting standard formalities

- Accept simplified, incomplete or summary declaration,
- Admit essential/emergency goods temporarily,
- Accept TIR carnet
- Waive the penalties imposed for delays
- Accept electronic documents

## Facilitate Trade for Emergency Goods

Reduce or eliminate tariffs

Reduce or eliminate other taxes

Set up appropriate warehousing facilities

Take measures to accelerate immediate clearance

Establish fast lanes

Use automation, electronic data processing and epayments

Procure, deploy and use non-intrusive technology equipment at customs clearance

Announce the faster customs houses

Enable cross-border transmission and processing of crisis related data Publish information on the classification of emergency / essential goods

Avoid disruptions in the production of essential goods

Establish and implement AEO program

### **Sustain Supply Chains**

Simplify procedures and regulations for exports of intermediary goods Refrain from imposing export prohibitions, barriers or additional taxes

Speed up customs procedures

Implement prearrival processing & maximize the use of fast tract lanes

Ensure smooth operation of transportation

Provide regular updates on rules and procedures

Expedite the clearance of importation of critical equipment and raw materials

Allow the electronic submission of data prior to the arrival of goods

Allow importers and exporters to defer duties, taxes and fees



Reduce or eliminate fees and charges associated with trade licenses



Maintain effective communication channels with business representatives



Extend time frames for filing claims and appeals
