The Strategy clearly puts forward that "data collection in many COMCEC members is inadequate to either limited capacity in data collection or lack of awareness regarding its importance" and additionally underlines that "Unavailability of reliable data hampers producing a sound analysis of the sectors and hence, an effective cooperation framework". In this respect, the workshop aims to enhance data collection and data analysing capacity, increase quality of service in related statistics and increase institutional capacity.
