# The IsDB Technical Assistance Program (TAP) for Regional and Global Integration in Trade

#### INTRODUCTION

The IsDB regularly submits progress reports on the implementation of the Technical Assistance Program (TAP) to the COMCEC meetings. This report highlights the major WTO-related technical assistance activities undertaken under this program since the 37<sup>th</sup> Session of the COMCEC held in Istanbul, Turkey, in November 2019.

The Technical Assistance Program (TAP) for Regional and Global Integration in Trade – formerly the WTO Program - assists IsDB 57 - Member Counties in their efforts to integrate among themselves and with the world through training, policy advice and technical assistance. The interventions under this program aim at rapid integration and increasing connectivity - this is expected to generate global opportunities for Member Counties as they become more integrated with the global market.

### Background.

The IsDB WTO-related Technical Assistance and Capacity Building Program (WTO-Program) was launched in 1997 with the prime objective of helping its member countries upgrade their human and institutional capacities to adjust to the new multilateral trading system. The aim of the Program is to provide greater awareness to the OIC member countries on WTO Agreements and their implementation and facilitate the process of their accession to the WTO. It also serves as a forum where relevant officials from member countries can exchange views and discuss various multilateral trade matters. In the recent years, the focus of the Program has been more on helping the member countries in their accession to WTO, strengthening their negotiation skills on issues related to the framework of the Doha Work Program. The program was later renamed as the IsDB Technical Assistance Program (TAP) for Regional and Global Integration in Trade aims to build the institutional and human capacities of IsDB MCs in the area of Multilateral Trade Negotiations, such as those conducted under the auspices of the WTO, including acting as an interface with regional trading arrangements with the view to facilitating their effective participation into the global economy and fostering regional integration.

Major elements of the program: The main elements of the IsDB Group's TAP program include organizing seminars and workshops on WTO and other regional agreements; conducting technical courses on Trade Policy; organizing Consultative Meetings on important issues and in preparation for the WTO Ministerial Conferences; undertaking WTO-related studies; and providing advisory services through financing of experts/consultants to member countries on WTO-related matters. Briefly, the activities that have been undertaken under the IsDB Group's TAP Program since its inception are as follows:

I. <u>Seminars and Workshops</u>: The IsDB organizes seminars and workshops covering a wide range of regional integration and trade issues with the aim of familiarizing member countries with the contents and provisions of the regional trade and WTO Agreements as well as the activities of WTO to help to be in a better position to defend their interests. Until the end-September 2021, around 174 Seminars and Workshops have been organized by IsDB under this program.



- II. <u>Trade Policy Courses</u>: Organized in collaboration with the WTO, these courses are short versions of the WTO Trade Policy Course which is a three-month course offered by the WTO in Geneva. The Trade Policy Course covers a wide range of topics, such as, market access, customs and trade administration, agriculture, textile and clothing, sanitary and photo-sanitary measures, technical barriers to trade, government procurement, general agreements on trade in services, intellectual property rights, anti-dumping, subsidies and countervailing measures, dispute settlement, agreement on trade-related investment measures, trade and competition policy, trade and environment, and regionalism. Since the inception of the Program till now, Trade Policy courses also have been organized by the IsDB under this program
- III. <u>Special Studies:</u> The IsDB occasionally undertakes in-depth studies on WTO-related issues based on the requests of member countries. So far, the IsDB has undertaken studies on: Agriculture sector, Investment, Services sector, Trade-related Aspects of Intellectual Property Rights (TRIPs), and Electronic-Commerce. Each study included a set of case studies on OIC member countries and contained valuable practical tips and negotiation strategies on the various issues concerning the OIC member countries
- IV. <u>Consultative Meetings:</u> The IsDB organizes consultative meetings for the member countries mostly in conjunction with the WTO Ministerial Conferences. These meetings provide a forum for the delegations of member countries to exchange views and, where possible, coordinate their positions on matters related to the WTO, adopt a common stance and act as a group to acquire stronger bargaining power. So far, the IsDB has organized nine consultative meetings for both capital-based and Geneva-based officials
- V. <u>WTO Specific Technical Assistance to OIC Member Countries:</u> The IsDB also provides specific technical assistance to member countries through hiring consultancy services or fielding in-house WTO experts on vital WTO issues such as, WTO accession, drafting of national laws, establishing WTO Units and providing capacity building for all general purposes

It is worth mentioning that in December 2019, the Islamic Development Bank launched its Regional Cooperation and Integration Policy and Strategy (RCI). The RCI Policy/Strategy are intended to address the priority needs of IsDB Member Countries and to improve effectiveness and efficiency of IsDB interventions. The RCI policy/strategy will enable IsDB to become a primary connecting platform for Member Countries, Regional Cooperation Organizations and relevant communities to cooperate with each other. Strengthen economic cooperation among MCs and enable greater trade and investment with the global economy.

#### ACTIVITES PLANNED/ORGANIZED AFTER THE 38th SESSION OF THE COMCEC

Based on the feedback and requests of member countries, the TAP Program is currently focusing on two themes: (i) Accession and other matters related to the WTO and (ii) Regional integration. So challenges were faced during the COVID19 crisis caused some delays in implementing some TAP activities in 2020. The important activities organized/planned by the IsDB since the 37<sup>th</sup> Session of the COMCEC are the following:
