Over the past decade, the protracted conflict in Syrian Arab Republic has had a profound and lasting impact on the country's rural regions—areas that once served as vital centers of agricultural production, employment, and local economic resilience. The cumulative effects of large-scale displacement, destruction of critical infrastructure, disruption of agricultural systems, and limited access to markets and services have severely diminished rural livelihoods and undermined food security.

In this context, the revitalization of rural economic activity is not only an urgent humanitarian and development priority, but also a strategic entry point for broader stabilization, social cohesion, and post-conflict recovery. Reactivating rural economies requires a multidimensional approach simultaneously addressing infrastructure rehabilitation, agricultural recovery, and employment generation, while promoting inclusive governance and community-based resilience.

In light of the importance of the issue, the panel titled 'Revitalization of Economic Activities in Rural Areas of the Syrian Arab Republic' will be held on November 2nd, 2025, during the 41st Session of the Ministerial Meeting. In this sense, the panel aims to explore potential strategies and policies to revitalize economic activities in Syrian Arab Republic's rural areas.

The panel will consist of a moderator and three speakers. The speakers will address the delegates of the OIC Member States, including ministers from the Islamic World as well as representatives of International organizations, civil society organizations and the academia. It will last a total of one and half hour, with each speaker being allotted 15 minutes to speak.



Dr. Sinan HATAHET

- Holds a Ph.D. degree in computer science and focused on issues specifically in MENA region.
